

# SB 1029/HB 2640 Budget Reconciliation; Higher Education

## First Regular Session 2009

Vetoed by Gov. Brewer on 7/1/09

**Summary of Legislation:** This legislation would suspend capital outlays for FY 2009-2010; funds dual enrollment at 50% and appropriate \$100 million of FY 2010-2011 budget to "repay" for \$100 million of FY 2009-2010 deferred payments to community colleges and universities.

### Vote Translation:

"YES" on bill = Vote to reduce funding for community colleges and universities.

"NO on bill = Vote to maintain previously allocated higher education budgets.
