

## 2010 SECOND REGULAR SESSION EDUCATION ACCOUNTABILITY & REFORM BILLS

In 2010, over 130 education-related bills were introduced in the second regular session. Of those, thirty-nine made it to the desk of Governor Brewer, where she signed them into law. Of those thirty-nine bills, thirty-three dealt with education accountability, reform or policy changes, as well as various administration and personnel issues. The thirty-three bills listed below are grouped into four categories: Education Policy and Reform, District Mandates and Reporting, Post-Secondary Institutions and Personnel.
